

# RÉMY COINTREAU

## Candidate Policy

The purpose of this **Candidate Policy** is to inform you, as a candidate, of the conditions under which we process your personal data in the context of the management of your application file.

The recruiting company of the Rémy Cointreau group is the data controller for the purposes of the Regulation (EU) 2016/679 on the protection of Personal Data (the “GDPR”). The address of the data controller can be found in the “Addresses of our sites” section below.

### Categories of data we collect

The categories of personal data concerning you that we process, insofar as they are provided to us, are the following:

- identification data, including surname and first name;
- contact details, including personal address, phone/mobile phone/fax number, e-mail address;
- sex, date of birth, nationality;
- information on previously job positions, including date of hiring, job position, department and unit, place of work, type of contract (full-time or part-time), data on work preferences and skills;
- curriculum vitae, including training, past professional experience, and references.

Most of the personal data we process is obtained from you when you apply. We may also obtain personal data about you during the application process (e.g. during interviews). Other categories of data may be obtained from third parties, including, for example, from recruitment agencies.

### Purposes of processing

We process the information you provided to us by email to identify and evaluate your application for the position at stake, to communicate with you during the recruitment process and to send you notifications about new job positions that may be relevant with your profile.

Otherwise, we will not be able to review your application.

If you are a successful candidate (i.e. the decision is made to recruit you), additional information will be requested in order to create the employment contract. You will receive at this time the specific details of the processing of your data through a separate document.

### Legal basis

The processing of your information is based on our legitimate interest to have an efficient follow-up of the recruitment process.

### How we share your information

We share your information with the following selected recipients:

- the HR department of the recruiting entity and the other companies of the Remy Cointreau Group;
- depending on the progress of your application in the recruitment process, with managers of the department concerned by your application;
- the people you have identified as references for your past experiences, so that they can identify you and give their feedback;
- third party providers for the provision of technical and support services related to the application and recruitment process (such as hosting services or recruitment agencies). In providing the services, the service provider will, if necessary, process your personal data on our behalf. For each third party we use, we verify that this third party provides sufficient guarantees regarding the confidentiality and security of your data. We will ensure that each of these third parties complies with our data security standards and our limitations on international transfers.

These recipients may be located in countries outside the European Economic Area ("EEA"). We have implemented appropriate safeguards to protect your privacy, fundamental rights and freedoms, and the exercise of your rights; for example, we implement an adequate level of data protection, usually through the European Commission's Standard Contractual Clauses.

### Retention periods

If your application is not successful, we will keep your profile data for a limited period of time, depending on local legislation, in order to contact you if any opportunity arises later on. At the end of this period, your personal data will be deleted. In France, the data retention period is 2 years as from our last contact. At the end of this period, your personal data will be deleted.

If you are a successful candidate, you will be provided with all explanations relating to the processing of your personal data, including the retention periods.

### Data security

We have implemented appropriate physical, technical and organizational security measures to protect your personal data from accidental or unlawful destruction, accidental loss or alteration, and unauthorized access or disclosure of such personal data.

### Your rights

You have the following rights in relation to the personal data we hold about you.

- Access. You have the right to access data we have collected about you.
- Correction. You have the right to require us to correct any personal data collected about you that is inaccurate or incomplete.
- Erasure. You may request that we erase certain of your personal data.
- Restriction of Processing. You have a right to require us to restrict the processing of the personal data we hold about you, under certain conditions.
- Objection. You have the right to object to the processing of your data.
