

PRIVACY POLICY

Our Privacy Policy describes how we collect, use and protect Personal Data (i.e. any information relating to an identified or identifiable person, referred to as a "Data Subject") on this website / app (hereafter, the "Website"). This Policy cover all users (hereinafter collectively, the "Users" or "You").

This website is operated by the company CLS Rémy Cointreau, located at 21 rue Balzac, 75008 Paris, France (hereinafter referred to as "Rémy Cointreau" or "We"), which is an entity of the Rémy Cointreau Group.

Rémy Cointreau acts as a data controller with regard to the applicable legislation and regulations on data protection, in particular: (i) the Privacy and Electronic Communications Regulations 2003 (which are derived from the Privacy and Electronic Communications Directive 2002/58/EC); (ii) the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (General Data Protection Regulation, hereinafter the "GDPR"), which entered into force on 25 May 2018 ; and (iii) all applicable laws, statutes, statutory instruments, orders, regulations and codes of practice (whether or not having the force of law) in force from time to time and which apply to the processing of your personal data- hereinafter collectively referred to as the "Applicable Laws".

1-Information collected

Personal Data that we collect on the Website includes:

- Your IP address and your localization (limited to country and postal code/city).
- Cookies, trackers and similar techniques necessary for the proper functioning of the website. For more information on how we use cookies, please see our Section 6.

2-Legal Basis and purposes of data processing

We use and process Personal Data about you to communicate information about the product in the language of the country where you are localized based on our legitimate interest to operate the website and, depending of the country, on compliance with the applicable legal and regulatory obligation ;

We also collect cookies, trackers and similar techniques to provide certain features to you based on our legitimate interest (for more information on how we use cookies, please see our Section 6).

3-Your rights

In accordance with the Applicable Law, you have the rights of access, rectification, erasure, restriction of processing, objection, portability of your personal data we hold about you to the extent applicable, unless we can demonstrate a compelling legitimate reason for retaining your Personal Data. 4- Recipients of the Data

Your Personal Data will not be transferred to or made accessible by third parties except to our affiliates, to our external advisors and to our service providers.

5-Data transfer and security measures

We may transfer your personal data to another country outside of the UK and European Union. Where we transfer your data to such third countries, we ensure an adequate level of protection for the transferred personal data by entering into data transfer agreements with the recipients of your personal data based on the European Commission's standard contractual clauses ("SCCs") or other valid transfer mechanisms and we carry out, in accordance with the European Court of Justice's decision of 16 July 2020 "Schrems II" (Case C 311-18) and with the guidance of the European Data Protection Board, a risk assessment of the transferred data. Please contact us if you would like to receive a copy of the safeguards in place to secure data transfers outside the European Economic Area.

Data is processed both manually and electronically and is protected by appropriate security measures. We will provide an adequate level of protection for your data and ensure that appropriate technical and organisational security measures are in place to protect your data against accidental or unlawful destruction, accidental loss or alteration, unauthorised disclosure or access and against all other forms of unlawful processing.

The same level of protection is contractually imposed by Rémy Cointreau on all its subcontractors. Any employee of Rémy Cointreau who, in the course of his or her duties, may have access to your personal data undertakes to hold it in strict confidence. However, as the Internet is not completely secure, we cannot guarantee that your personal information stored or sent will be completely safe. We encourage you to exercise caution when using the Internet to access our Website.

6- Cookies

This section on cookies explains how we use cookies to provide, protect and improve our website.

What is a cookie?

Cookies are text files with small pieces of data that uniquely identify your browser or device. The cookie is placed on your browser or device by the website or mobile application you visit. When you return to that website or mobile application (or visit other websites or mobile applications that use the same cookies), those websites recognize the cookies and your device.

What types of cookies do we use and how do we use them?

- **Cookies that are strictly necessary for the functioning of the website:**

These cookies are purely technical and strictly necessary for the proper functioning of the website, so they are not subject to your consent and cannot be disabled in our systems. They are generally set as a response to actions you have taken that constitute a request for services, such as setting your privacy preferences or logging in. You can set your browser to block or be informed of the existence of these cookies, but some parts of the website may be affected. These cookies do not store any personal data.

Duration of data retention

Cookies are stored on your terminal for as long as is necessary to achieve the purposes pursued, as described above. In particular:

- Cookies are stored on your device for a maximum of 13 months after they are created;
- The information collected via cookies is kept for 25 months from the date of their creation on your terminal.

7- Data Retention

Your Data will be retained, in a form that allows you to be identified, only for as long as is necessary for the purposes described in this Privacy Policy, or for as long as is necessary to comply with any legal obligation.
